Total fees payable

Provisionally selected candidates will be required to deposit an amount of **Rs.1,28,000**/- for admission to B.E. programme and **Rs.1,35,000**/- for admission to B.Arch. programme by crossed Demand draft in favour of "**Birla Institute of Technology**, payable at Ranchi. The candidate may also pay the admission fee through State Bank Collect by using the net banking or debit / credit card payment of any nationalized bank. For detail, please see Institute website. **No partial payment shall be entertained.**

In addition to the above, students will also be required to deposit Hostel Caution Money* (One Time only - Refundable) of Rs.5,000/- and suitable mess advance at the beginning of each semester, which will be adjusted against their mess charges. For the session July 2017, this mess advance* will be Rs. 20,000/- [total of Rs. 25,000/-]
