## Candidates may please note the following:

- Eligible candidates who have applied for the M.Tech., MUP and M.Sc. programmes, including sponsored candidates, to be available on email and mobile phone by 8:30 am onwards on 14<sup>th</sup> and 15<sup>th</sup> May 2025.
- The **Test/ Counselling** for each programme will be **online**.

At the time of the counselling, candidates will be required to produce (show online) the following documents and certificates in original.

- 1. Pass certificate of Class 10
- 2. Marksheet of Class 10
- 3. Marksheet of Class 12 / Intermediate or equivalent
- 4. Certificates and marksheets of graduation / qualifying examination

OR

Marksheets up to pre-final year for candidates who would be completing qualifying examination in 2025.

Candidates with qualifications acquired through correspondence or distance-learning programmes must show proof of pass certificate, marksheets of qualifying examination and approval of DEC (Distance Education Council).

- 5. Admit card and Score card of GATE/ JAM (if applicable).
- 6. Caste certificate / special category certificate (if applicable).
- 7. Photo identification: (Driving license, Passport, PAN Card, Voter ID, Aadhaar Card, College ID, Employee Identification Card are acceptable).

Provisionally selected candidates will be required to submit all the above Documents / Certificates (except photo ID) in original at the time of admission.

Provisionally selected candidates who have appeared for final examinations will be required to sign an undertaking at the time of admission on Non-Judicial Stamp Paper of Rs. 20/- to the effect that if they fail to obtain the requisite marks in graduation / postgraduation their admission will be automatically cancelled. The deadline for submission of mark-sheet / degree certificate is 31 October 2025, failing which the provisional admission will be cancelled.
