Guidelines for Provisionally Selected candidates for Diploma in Engineering Programs 2026-27

Based on data provided in the online application forms, the applicants have been provisionally selected for admission on merit for full-time Diploma in Engineering Program of the Institute at its BIT Mesra University Polytechnic) [based on their marks in Class 10th or equivalent examination].

Candidates may please note the following:

1. The list of provisionally selected candidates is available at Results/ Updates Section for each round / direct admission.
2. Applicants who have been allotted a seat will be required to pay the admission fee through Online Payment Gateway (as shared on your registered email id) **by last date as mentioned in the results**, failing which your admission offer will liable to be cancelled.
3. After payment of Admission and first semester fees, candidate is required to physically report at University Polytechnic, BIT Mesra campus for document verification

FEES PAYABLE: Applicants will be required to pay admission fee (1st semester) i.e. **Rs.60,000 for BIT Mesra (University Polytechnic)**, Candidate may use the net banking or credit card payment through any Scheduled bank by the due date.

ENROLLMENT NUMBERS: Institute enrollment numbers will be issued after receiving the admission fee and successful physical document verification.

CLASSES SHALL TENTATIVELY BEGIN FROM LAST WEEK OF JULY/ FIRST WEEK OF AUGUST (EXACT DATES SHALL BE NOTIFIED IN ACADEMIC CALENDAR FROM DEAN (UNERGRADUATE STUDIES) OFFICE. YOU ARE ADVISED TO VISIT THE INSTITUTE WEBSITE PERIODICALLY FOR UPDATES.

VERIFICATION OF DOCUMENTS: The document verification shall be done at the allotted campus. In case, any information/document provided by the applicant online is found to be incorrect / inaccurate / false, the admission of such applicants is liable to be cancelled and all fees paid by the applicant shall be forfeited. Decision of the Vice Chancellor, BIT Mesra will be final in such matters.

Applicants will be required to furnish the following documents/certificates in original as well as one set of photocopies during verification of documents at a later stage.

1. Pass Certificate and Marksheet of Class 10
2. School Leave Certificate (SLC)
3. Migration Certificate
4. Residential Certificates of Jharkhand State issued by SDO/CO
5. Caste certificate (if applicable), in proper format, signed by appropriate authority of rank not less than SDO/CO(for Reserved Category only).
6. Online Payment through ERP Portal receipt.
7. Special category certificate (if applicable), in proper format, from appropriate authority.
8. One recent passport size photograph, identical to uploaded on the Application Form.
9. OBC-NCL / EWS certificate shall be issued on or after 01st April, 2026.
10. ABC ID.
11. Anti ragging affidavit.
12. Printout copy of application form.
