## **1<sup>st</sup> Provisional Selection List Candidates for IMSc(Chemistry) Program 2022**

Following are the lists of candidates provisionally selected on merit for the full-time IMSc(Chemistry) at Mesra, based on their Entrance Exam scores and Interview held ONLINE on 20<sup>th</sup> July 2022.

### **Candidates may please note the following:**

1. All applicants are advised to check their seat allotment / result online by clicking on the admission application link given on the website.
2. Please enter your application number and password created during filling the online application form.
3. Click on the "Notification(s)" tab and see your seat allotment status.
4. Applicants who have been allotted a seat will be required to report at the campus for admission by **29.07.2022** and pay the admission fee through Online Payment Gateway (URL given below), failing which your admission offer will be liable to be cancelled and will not be considered for further round of seat allotment, if any. **[The Institute will remain closed on Saturday and Sunday].**

### **List of documents to carry at time of reporting for admission:**

At the time of admission, selected candidates would be required to show the originals of the following documents/ certificates **and submit the College Leaving Certificate, Migration Certificate and Caste certificate in original along with self-attested photocopies of the all documents / certificates.** Rest documents / certificates may be withdrawn immediately after verification by submitting "Undertaking Form".

1. Pass certificate of Class 10
2. Marksheet of Class 10
3. Marksheet of Class 12 / Intermediate or equivalent
4. Certificates and marksheets of qualifying examination OR

Marksheets upto pre-final year for appearing candidates of graduation / qualifying examination in 2022. They must bring a certificate in original from the Principal of Institute stating that:

- (a) by 30<sup>th</sup> June 2022, (s)/he will have appeared for examination in all subjects required for obtaining his/her qualifying degree.
  - (b) (s)/he has obtained requisite marks or equivalent based on latest available grades / marks.
5. **Candidates with qualifications acquired through correspondence or distance-learning programmes must carry proof of pass certificate and mark sheets of qualifying examination and approval of DEC (Distance Education Council).**
  6. Caste certificate / special category certificate (if applicable).
  7. College Leaving Certificate
  8. Migration Certificate
  9. One recent passport size photograph, identical to the photograph affixed in the application form.
  10. Candidates who have appeared / are appearing for final examinations in 2022 (i.e. whose complete set of marksheets upto final year are not available) will be required to bring an undertaking on Non-Judicial Stamp Paper of Rs. 20/- (please see Information Brochure 2022

(pdf) on website for format of undertaking).

Provisionally selected candidates who have appeared for final examinations in 2022 will be required to sign an undertaking at the time of admission on Non-Judicial Stamp Paper of Rs. 20/- to the effect that if they fail to obtain the requisite marks in qualifying examination, their admission will be cancelled. The deadline for submission of mark-sheet / degree certificate is 31<sup>st</sup> October 2022, failing which the provisional admission will be cancelled. #### **Total fees payable at the time of admission**

Provisionally selected candidates will be required to deposit requisite fee (as mentioned in the below table) at the time of admission. All payments must be made online. For details, please go through the instructions given on the Institute website. **[Candidate may use the net banking or creditcard payment through any nationalized bank].**

**Students will be required to deposit Hostel Caution Money\* (One Time only - Refundable) of Rs.5,000/-. They will also be required to pay suitable mess advance at the beginning of each semester, which will be adjusted against their mess charges. For the July 2022 session, this mess advance\* will be Rs. 20,000/- [Total of Rs. 25,000/-].**
