Provisional Selection list for MBA Programme 2017 at BIT Mesra (Main Campus), BIT Lalpur and BIT Noida Campuses– 2nd List

In continuation of our previous notice Ref/Adm/MBA Results 2017 / 2017-18 / MBA-Results-1, dated 15 May 2017, the following candidates from the waiting list are also provisionally selected on merit for the full-time MBA programme 2017 at Mesra (Main Campus), BIT Lalpur and BIT Noida Campuses, based on their performance in GD & PI. This list is being placed on the Notice Boards of the Institute at Mesra (Main Campus), its concerned Campuses, and on the Institute website.

All provisionally selected candidates are required to **report in person and take admission at** the Campus mentioned against their names, during working hours on any working day by 5th June 2017, failing which their admission offer will liable to be cancelled and will not be considered for further round of seat allotment / upgradation, if any. [The Institute will remain closed on Saturday and Sunday].

Details of vacant seats existing after 5th June 2017, if any, will be notified on the Institute website on or **before 7th June 2017**, along with necessary details.

At the time of admission, selected candidates would be required to show the originals of the following documents / certificates and **submit the College Leaving Certificate**, **Migration Certificate & Caste certificate in original.** <u>Rest documents / certificates may be withdrawn immediately after verification by submitting "Undertaking Form" available in the Admission Office of the campus.</u>

- 1. Pass Certificate and Marksheet of Class 10
- 2. Marksheet of Class 12 / Intermediate or equivalent
- 3. Marksheets of Graduation for graduates
- OR

Marksheets upto pre-final year for candidates graduating in 2017. They must also bring a certificate in original from the Principal of Institute stating that:

- a. by **30th June 2017**, (s)/he will have appeared for examination in all subjects required for obtaining his/her Bachelor's degree.
- b. He / She has obtained 50% (45% for SC/ST) marks or equivalent, based on latest available grades / marks.
- c. Undertaking Please see below*
- 4. Candidates with qualifications acquired through correspondence or distancelearning programmes must carry proof of pass certificate, marksheets of qualifying examination and approval of DEC (Distance Education Council).
- 5. Printout of Admit Card / Hall Ticket of CAT 2016 / XAT 2017 / CMAT 2017 / MAT Sept-2016 or MAT Dec-2016 or MAT Feb-2017 [as received by e-mail]
- 6. Printout of Score Card of CAT 2016 / XAT 2017 / CMAT 2017/ MAT Sept-2016 or MAT Dec-2016 or MAT Feb-2017.
- 7. Caste certificate (if applicable), in proper format, signed by appropriate authority of rank not less than SDO.
- 8. Special category certificate (if applicable), **in proper format**, from appropriate authority.
- 9. One recent passport size photograph, identical to uploaded on the Application Form.

*Provisionally selected candidates who are appearing for their final examinations in 2017 will be required to submit an undertaking at the time of admission on **Non-Judicial Stamp Paper of Rs. 20/-,** countersigned by their guardian, to the effect that if they fail to obtain requisite marks in Honours / aggregate in graduation their admission will be cancelled. The deadline for submission of mark-sheet / degree certificate **is 31 October 2017**, failing which the provisional admission will be automatically cancelled. (Please see Sec-10 in MBA Information Brochure 2017 (pdf) on website for format of undertaking).

Total fees payable at the time of admission:

Provisionally selected candidates will be required to deposit an amount of **Rs.1,40,500**/- for admission to MBA programme at Mesra, and **Rs.1,27,000**/- for admission to MBA programme at BIT Lalpur and BIT Noida Campuses.

All payments must be made by crossed demand draft in favour of Birla Institute of Technology,

- > Payable at Ranchi, in case of Mesra or Lalpur Campuses
- Payable at Noida in case of Noida Campus

Hostel facilities are provided only at the Main Campus at Mesra. Hostel mess charges at Mesra will be approximately Rs.3,000/- per month. Students at Mesra will be required to deposit Hostel Caution Money* (One Time only - Refundable) of Rs.5,000/-. They will also be required to pay suitable mess advance at the beginning of each semester, which will be adjusted against their mess charges. For the session July 2017, this mess advance* will be Rs.20,000/- [total of Rs. 25,000/-].

*Hostel Caution Money (One Time only - Refundable) and Hostel Mess Advance (each semester) are payable by crossed Demand Draft in favour of "BIT Hostels Mess Account" payable at Ranchi.

Admission fee (except Hostel Mess Advance) may also be paid online through State Bank Collect [candidate may use the net banking or debit / credit card payment through any nationalized bank]. For details, please visit Institute website <u>www.bitmesra.ac.in</u>.

Note: Candidates, whose campus have been upgraded to BIT Mesra will be required to show the fee receipt issued by the previous campus and pay the additional fee at the time of admission, if any. For details, please refer fee structure available on the Institute website.
