All provisionally selected candidates are required to report in person at Mesra and take admission during working hours on any working day by 05 June 2018, failing which their admission offer will liable to be cancelled. [The Institute will remain closed on Saturday and Sunday].

Details of vacant seats existing after **05** June **2018**, if any, will be notified on the Institute website on or **before 06** June **2018**, along with necessary details.

At the time of admission, selected candidates would be required to show the originals of the following documents/certificates and submit the College Leaving Certificate, Migration Certificate and Caste certificate in original. Rest documents / certificates may be withdrawn immediately after verification and by submitting "Undertaking Form" available in the Admission Office of the campus.

- 1. Pass Certificate and Marksheet of Class 10
- 2. Marksheet of Class 12 / Intermediate or equivalent
- 3. Marksheets of Graduation for graduates

Marksheets upto pre-final year for candidates graduating in 2018. They must also bring a certificate in original from the Principal of Institute stating that:

- a. by **30**th **June 2018**, he/she will have appeared for examination in all subjects required for obtaining his/her Bachelor's degree.
- b. He/ She has obtained 50% (45% for SC/ST) marks or equivalent, based on latest available grades / marks.
- c. Undertaking Please see below*
- 4. Candidates with qualifications acquired through correspondence or distance-learning programmes must carry proof of pass certificate, marksheets of qualifying examination and approval of DEC (Distance Education Council).
- 5. Printout of Admit Card / Hall Ticket of CAT 2017 / XAT 2018 / CMAT 2018 / MAT Sept-2017 or MAT Dec-2017 or MAT Feb-2018 [as received by e-mail]
- 6. Printout of Score Card of CAT 2017 / XAT 2018 / CMAT 2018 / MAT Sept-2017 or MAT Dec-2017 or MAT Feb-2018.
- 7. Caste certificate (if applicable), in proper format, signed by appropriate authority of rank not less than SDO.
- 8. Special category certificate (if applicable), in proper format, from appropriate authority.
- 9. One recent passport size photograph, identical to uploaded on the Application Form.

*Provisionally selected candidates who are appearing for their final examinations in 2018 will be required to submit an undertaking at the time of admission on Non-Judicial Stamp Paper of Rs. 20/-, countersigned by their guardian, to the effect that if they fail to obtain requisite marks in Honours / aggregate in graduation their admission will be cancelled. The deadline for submission of mark-sheet / degree certificate is 31 October 2018, failing which the provisional admission will be automatically cancelled. (Please see Sec-10 in MBA Information Brochure 2018 (pdf) on website for format of undertaking).

Total fees payable at the time of admission:

Provisionally selected candidates will be required to deposit an amount of Rs.1,51,500/- for admission to MBA programme at Mesra.

All payments must be made by **crossed demand draft** in favour of **Birla Institute of Technology**, Payable at Ranchi.

Candidates, whose seats have been upgraded at Mesra (from BIT Lalpur or BIT Noida campus) should pay the differential fee at the time of reporting for admission. They are also advised to carry the proof of admission fee paid along with documents submitted at previous Campus.

In addition to the above, candidates will be required to deposit Hostel Caution Money* (One Time only - Refundable) of Rs.5,000/- and suitable mess advance at the beginning of each semester, which will be adjusted against their mess charges. For the session July 2018, this mess advance* will be Rs.20,000/- [total of Rs. 25,000/-].

*Hostel Caution Money (One Time only - Refundable) and Hostel Mess Advance (each semester) are payable by crossed Demand Draft in favour of "BIT Welfare Society" payable at Ranchi.

Admission fee (except Hostel Mess Advance) may also be paid online through State Bank Collect [candidate may use the net banking or credit card payment through any nationalized bank]. For details, please visit Institute website www.bitmesra.ac.in.

Registration for the 1st semester will be done on 9th July 2018. Regular classes will commence from 10th July 2018 at all Campuses.
