Provisional Selection list for MBA Programme 2019 at BIT Noida Campus, against vacant seats

Subsequent to GD & PI conducted on 24th June 2019 at Noida, the following candidates have been provisionally selected on merit for the full-time MBA programme at Noida, based on their performance in GD & PI. This list is being placed on the Notice Boards of the Institute and on the Institute website.

All provisionally selected candidate is advised to report in person at Mesra and take admission, during working hours from 1st July 2019 to 3rd July 2019, failing which their admission offer will liable to be cancelled.

At the time of admission, selected candidates would be required to show the originals of the following documents/certificates and submit the **College Leaving Certificate, Migration Certificate and Caste certificate in original**. Rest documents / certificates may be withdrawn immediately after verification and by submitting "Undertaking Form" available in the Admission Office of the campus.

1. Pass Certificate and Marksheet of Class 10
2. Marksheet of Class 12 / Intermediate or equivalent
3. Marksheets of Graduation for graduates
OR
Marksheets upto pre-final year for candidates graduating in 2019. They must also bring a certificate in original from the Principal of Institute stating that:
 - a. by 30th June 2019, he/she will have appeared for examination in all subjects required for obtaining his/her Bachelor's degree.
 - b. He/ She has obtained 50% (45% for SC/ST) marks or equivalent, based on latest available grades / marks.
 - c. Undertaking - Please see below*
4. **Candidates with qualifications acquired through correspondence or distance-learning programmes must carry proof of pass certificate, marksheets of qualifying examination and approval of DEC (Distance Education Council).**
5. Printout of Admit Card / Hall Ticket of CAT 2018 / XAT 2019 / CMAT 2019 / MAT Sept-2018 or MAT Dec-2018 or MAT Feb-2019 or MAT May-2019 [as received by e-mail]
6. Printout of Score Card of CAT 2018 / XAT 2019 / CMAT 2019 / MAT Sept-2018 or MAT Dec-2018 or MAT Feb-2019 or MAT May-2019.
7. **Caste certificate (if applicable), in proper format, signed by appropriate authority of rank not less than SDO.**
8. Special category certificate (if applicable), in proper format, from appropriate authority.
9. One recent passport size photograph, identical to uploaded on the Application Form.

***Provisionally selected candidates who are appearing for their final examinations in 2019 will be required to submit an undertaking at the time of admission on Non-Judicial Stamp Paper of Rs. 20/-, countersigned by their guardian, to the effect that if they fail to obtain requisite marks in Honours / aggregate in graduation their admission will be cancelled. The deadline for submission of mark-sheet / degree certificate is 31 October 2019, failing which the provisional admission will be automatically cancelled. Total fees payable at the time of admission:

Provisionally selected candidates will be required to deposit an amount of **Rs.1,50,500/-**.

Mode of payment:

2. Through DD in favour **“Birla Institute of Technology” payable at Noida.**
