Based on data provided in the online application forms, following candidates are being called for verification of documents cum GD & PI [based on their score / total percentile in CAT 2018 / XAT 2019 / CMAT 2019 / MAT Sept 2018 or MAT Dec-2018 or MAT Feb 2019] for the full-time MBA (Master of Business Administration) programme at BIT Jaipur, BIT Lalpur and BIT Noida Campuses as per schedules given below.

The list is being placed on the Notice Boards of the Institute at Mesra and concerned Off Campuses.

Please see below for details of documents to carry at time of reporting for verification of documents cum GD & PI and fees payable at time of admission.

The selection will be made based on performance in Group Discussion & Personal Interview (GD & PI). The Campus-wise list of provisionally selected candidates will be announced by 5 pm on the Notice Boards of the Institute at Mesra and concerned Off Campuses only. No individual intimations will be sent to candidates.

Selected candidates will be required to take admission at the allotted Campus by the given period during office hours on working days.

### List of documents to carry at time of reporting for documents verification cum GD & PI:

At the time of reporting for verification of documents cum GD & PI, candidates must carry the following documents in original and submit self-attested photocopies of the same. If provisionally selected, they will be required to show / submit the same documents in original at the time of admission.

- 1. A print-out of the duly completed online form (original copy)
- 2. One recent colour photograph [same as uploaded on the form]
- 3. Payment receipt towards application fee of Rs.2,500/- (General/ OBC) and Rs.1,500/- (SC/ST) candidates (non-refundable)
- 4. Original of the following documents / certificates: Candidates must carry the originals of the following documents at the time of reporting for GD & PI, as well as one set of photocopies:
  - a). Pass certificate and Marksheet of Class 10
  - b). Marksheet of Class 12 / Intermediate or equivalent
  - c). Marksheets of Graduation for graduates
    OR
  - d). Marksheets upto pre-final year for candidates graduating in 2019. They must also bring a certificate in original from the Principal of Institute stating that:
    - i. By **30**<sup>th</sup> **June 2019**, he/she will have appeared for examination in all subjects required for obtaining his/her Bachelor's degree.
    - ii. He/she has obtained requisite marks or equivalent, based on latest available grades / marks.

- e). Candidates with qualifications acquired through correspondence or distance-learning programmes must carry proof of pass certificate, marksheets of qualifying examination and approval of DEC (Distance Education Council).
- f). Printout of Admit Card / Hall Ticket of CAT 2018 / XAT 2019 / CMAT 2019 / MAT Sept -2018 or MAT Dec-2018 or MAT Feb-2019 [as received by e-mail]
- g). Printout of Score Card of CAT 2018 / XAT 2019 / CMAT 2019 / MAT Sept -2018 or MAT Dec-2018 or MAT Feb-2019
- h). Caste certificate (if applicable), which should be in proper format and signed by appropriate authority of rank not less than SDO.
- i). Candidates belonging to other special categories (Persons with Disability [PwD], Kashmiri Migrant and Ward of BIT employee) must provide a certificate in proper format from appropriate authority.
- 5. Photo identification: (Driving license, Passport, PAN Card, Voter ID, College ID, Aadhaar Card, Employee Identification Card are acceptable)

NB: Without original of above documents  $\prime$  certificates, no candidates will be permitted to appear in the GD & PI.

Documents required at the time of admission:

If selected, candidates will be required to submit all the above documents in original (except the Photo ID) at the time of admission, along with the requisite fees.

Provisionally selected candidates who are appearing for their final examinations in 2019 will be required to submit an undertaking at the time of admission on Non-Judicial Stamp Paper of Rs. 20/-, countersigned by their guardian, to the effect that if they fail to obtain the requisite marks in Honours / aggregate in graduation their admission will be cancelled. The deadline for submission of mark-sheet / degree certificate is 31 October 2019, failing which the provisional admission will be cancelled. Such candidates are thus advised to prepare the above undertaking earlier, for their own convenience. #### Total fees payable at the time of admission:

Provisionally selected candidates will be required to deposit an amount Rs. 1,50,500/-.

All payments must be made online through State Bank Collect. For details, please go through the instructions given on the Institute website. [Candidate may use the net banking or credit card payment through any nationalized bank].

For fee refund rule, please see separate notice on Notice Board.

Registration of the admitted candidates will be done a day before commencement of classes. Regular classes will commence from 16<sup>th</sup> July 2019 at all Campus [Exact date will be notified at later stage].

**Note:** All shortlisted applicants called for verification of documents cum GD & PI, are allowed to appear at GD&PI on **purely provisional basis**, subject to their eligibility being verified at the time of documents verification. Merely being allowed to appear at the GD&PI will not be considered as a ground for being eligible for admission.
