# Provisional Selection list for MBA Programme 2019 at BIT Mesra (Main Campus) - 4<sup>th</sup> List

In continuation of our previous notice Ref/Adm/MBA Results 2019/2019-20/MBA-Results -3, dated 19<sup>th</sup> April 2019, the following candidates from the waiting list are also provisionally selected on merit for the full-time MBA programme at Mesra (Main Campus), based on their performance in GD & PI conducted during 28<sup>th</sup> & 29<sup>th</sup> March 2019. This list is being placed on the Notice Boards of the Institute and on the Institute website.

All provisionally selected candidates are required to **report in person and take admission**, during working hours on any working day by 23<sup>rd</sup> July 2019, failing which their admission offer will liable to be cancelled. [The Institute will remain closed on Saturday and Sunday].

At the time of admission, selected candidates would be required to show the originals of the following documents/certificates and submit the College Leaving Certificate, Migration Certificate and Caste certificate in original. <u>Rest documents / certificates may be withdrawn immediately after verification and by submitting "Undertaking Form" available in the Admission Office of the campus.</u>

- 1. Pass Certificate and Marksheet of Class 10
- 2. Marksheet of Class 12 / Intermediate or equivalent
- 3. Marksheets of Graduation for graduates OR

Marksheets upto pre-final year for candidates graduating in 2019. They must also bring a certificate in original from the Principal of Institute stating that:

- a. by **30**<sup>th</sup> **June 2019**, he/she will have appeared for examination in all subjects required for obtaining his/her Bachelor's degree.
- b. He/ She has obtained 50% (45% for SC/ST) marks or equivalent, based on latest available grades / marks.
- c. Undertaking Please see below\*
- 4. Candidates with qualifications acquired through correspondence or distancelearning programmes must carry proof of pass certificate, marksheets of qualifying examination and approval of DEC (Distance Education Council).
- 5. Printout of Admit Card / Hall Ticket of CAT 2018 / XAT 2019 / CMAT 2019 / MAT Sept-2018 or MAT Dec-2018 or MAT Feb-2019 [as received by e-mail]
- 6. Printout of Score Card of CAT 2018 / XAT 2019 / CMAT 2019 / MAT Sept-2018 or MAT Dec-2018 or MAT Feb-2019.
- 7. Caste certificate (if applicable), in proper format, signed by appropriate authority of rank not less than SDO.
- 8. Special category certificate (if applicable), in proper format, from appropriate authority.
- 9. One recent passport size photograph, identical to uploaded on the Application Form.

\*Provisionally selected candidates who are appearing for their final examinations in 2019 will be required to submit an undertaking at the time of admission on Non-Judicial Stamp Paper of Rs. 20/-, countersigned by their guardian, to the effect that if they fail to obtain requisite marks in Honours / aggregate in graduation their admission will be cancelled. The deadline for submission of mark-sheet / degree certificate is 31 October 2019, failing which the provisional admission will be automatically cancelled. (Please see Sec-10 in MBA Information Brochure 2019 (pdf) on website for format of undertaking).

Total fees payable at the time of admission:

Provisionally selected candidates will be required to deposit an amount of Rs.1,64,000/-

All payments must be made online through State Bank Collect. For details, please go through the instructions given on the Institute website. [Candidate may use the net banking or credit card payment through any nationalized bank].

In addition to the above, students at Mesra will be required to deposit Hostel Caution Money\* (One Time only - Refundable) of Rs.5,000/-. They will also be required to pay suitable mess advance at the beginning of each semester, which will be adjusted against their mess charges. For the session July 2019, this mess advance\* will be Rs.20,000/-

\*Hostel Caution Money (One Time only - Refundable) and Hostel Mess Advance (each semester) are payable by crossed Demand Draft in favour of "BIT Welfare Society" payable at Ranchi.

Candidates are advised to come prepared and join the classes. Registration of the admitted candidates will be done immediately after admission. Regular classes have already been commenced from 16<sup>th</sup> July 2019.
