Applicants may please note the following:

- 1. The list of provisionally selected candidates is available at the end of this notification.
- 2. Applicants who have been allotted a seat will be required to pay the admission fee through Online Payment Gateway (as shared on your registered email id) by 17.05.2024, failing which your admission offer will be liable to be cancelled and will not be considered for further round of seat allotment, if any.
- 3. After payment of Admission and first semester fees, candidate is required to physically report at allotted campus for document verification.

[The Institute will remain closed on Saturday and Sunday].

CLASSES: Schedule of Regular classes will be notified through the Academic Calendar MO 2024 which will be published on Institute website.

<u>VERIFICATION OF DOCUMENTS</u>: Physical verification of documents will be conducted during the admission. In case if any information/document provided by the applicant online is found to be incorrect / inaccurate / false, the admission of such applicants is liable to be cancelled and all fees paid by the applicant shall be forfeited.

Decision of the Vice Chancellor, BIT Mesra will be final in such matters.

DOCUMENTS REQUIRED DURING VERIFICATION

- 1. Print out of Application Form and Application Fee Receipt
- 2. Pass Certificate and Marksheet of Class 10
- 3. Marksheet of Class 12 / Intermediate or equivalent
- 4. Marksheets of Graduation for graduates

Marksheets upto pre-final year for applicants graduating in 2024. They must also bring a certificate in original from the Principal of Institute stating that:

- a. By......2024, he/she will have appeared for examination in all subjects required for obtaining his/her Bachelor's degree.
- b. He/ She has obtained 50% (45% for SC/ST) marks or equivalent, based on latest available grades / marks.
- c. Undertaking (available at Admission Office)
- 5. College Leave Certificate (CLC)
- 6. Migration Certificate
- 7. Applicants with qualifications acquired through correspondence or distance- learning programs must carry proof of pass certificate, marksheets of qualifying examination and approval of DEC (Distance Education Council).

OR

- 8. Printout of Score Card and Admit Card of CAT / XAT / CMAT/MAT If any other
- 9. Caste certificate (if applicable), in proper format, signed by appropriate authority of rank not less than SDO.
- 10. Special category certificate (if applicable), in proper format, from appropriate authority.
- 11. One recent passport size photograph, identical to uploaded in the Application Form.
- 12. Admission Payment Receipt (generated through ERP system of the Institute).

FEES PAYABLE: All applicants will be required to pay admission fee (1st Semester) i.e. **Rs. 2,11,500.00*(Rupees two lakhs eleven thousand five hundred only)** for admission at Mesra Campus and **Rs. 1,91,500.00(Rupees One lakh ninety one thousand five hundred only)** for admission at it Off Campuses Patna, Lalpur and Noida through Online Payment Gateway (applicant may pay the admission fee through credit card and net banking).

* Including Hostel Room Rent for 1st Semester.

For Mesra Campus: In addition to the above, students will be required to deposit Hostel Caution Money* (One Time only - Refundable) of Rs.5,000/- and suitable mess advance at the beginning of each semester, which will be adjusted against their mess charges. For the July 2024 session, this mess advance* will be Rs. 30,000/- [total of Rs. 35,000/-]. *Hostel Caution Money (One Time only - Refundable) and Hostel Mess Advance (each semester) are payable through SBI Collect in favour of "BIT Welfare Society" payable at Ranchi.

Note:

- a) Applicants will be required to produce the College Leaving Certificate, Migration Certificate, Caste certificate and CAT/XAT/CMAT/MAT Score card (if applicable) in original. <u>Documents / certificates may be withdrawn immediately after verification</u> and by submitting "Undertaking Form" available in the Admission Office of the campus.
