<u>Special Round and Guidelines for provisionally selected candidates for M.Pharm</u> Programme 2023

Provisional selection has been done on merit for full-time Master of Pharmacy Programme at Mesra, based on their GPAT scores and Counselling (for GPAT candidates) and Institute Screening Test and Counselling (for Non- GPAT candidates) held at Mesra. This list is based on request of the candidates who have been allotted seats in previous list but due to various reasons they have not taken admission. This is the last the for these candidates to take admission.

Provisionally selected applicants shall be required to pay the admission fee using Online Payment GPAT way through debit / credit card / net banking (URL given below) by 26.08.2023, failing which their admission offer will liable to be cancelled and shall not be considered for further round of seat allotment / upgradation, if any.

List of documents to carry at time of reporting for admission:

At the time of admission, selected candidates would be required to show the originals of the following documents/ certificates and submit the College Leaving Certificate, Migration Certificate and Caste certificate in original along with self-attested photocopies of the all documents / certificates. Rest documents / certificates may be withdrawn immediately after verification by submitting "Undertaking Form".

- 1. Pass certificate of Class 10
- 2. Marksheet of Class 10
- 3. Marksheet of Class 12 / Intermediate or equivalent
- 4. Marksheets of Graduation for graduates
- 5. Certificates and marksheets of qualifying examination

OR

Marksheets upto pre-final year for appearing candidates of graduation / qualifying examination in 2023. They must bring a certificate in original from the Principal of Institute stating that:

- (a) by 30th June 2023, (s)/he will have appeared for examination in all subjects required for obtaining his/her qualifying degree.
- (b) (s)/he has obtained requisite marks or equivalent based on latest available grades / marks.
- 6. Candidates with qualifications acquired through correspondence or distance-learning programmes must carry proof of pass certificate and marksheets of qualifying examination and approval of DEC (Distance Education Council).
- 7. Admit card and Score card of GPAT.
- 8. Caste certificate / special category certificate (if applicable).
- 9. College Leaving Certificate
- 10. Migration Certificate

- 11. One recent passport size photograph, identical to the photograph affixed in the application form.
- 12. Candidates who have appeared / are appearing for final examinations in 2023 (i.e. whose complete set of marksheets upto final year are not available) will be required to bring an undertaking on Non-Judicial Stamp Paper of Rs. 20/- (please see PG 2023 Information Brochure 2023 on website for format of undertaking).

Provisionally selected candidates who have appeared for final examinations in 2023 will be required to sign an undertaking at the time of admission on Non-Judicial Stamp Paper of Rs. 20/-to the effect that if they fail to obtain the requisite marks in graduation / Post-graduation their admission will be cancelled. The deadline for submission of mark-sheet / degree certificate is 31st October 2023, failing which the provisional admission will be cancelled. Total fees payable at the time of admission

Provisionally selected candidates will be required to deposit requisite fee (as mentioned in the below table) at the time of admission. All payments must be made online. Students will be required to deposit Hostel Caution Money* (One Time only - Refundable) of Rs.5,000/-.
