Provisional selection lists for M.Sc. (Biotechnology) and M.Sc. (Geoinformatics) programs 2018 – Admission against vacant seats

Subsequent to 2nd round of counselling against vacant seats held on **23rd July 2018** at Mesra, the following candidates are provisionally selected for admission on merit to the full-time M.Sc. Biotechnology and M.Sc. Geoinformatics Programs at Mesra, based on their academic records and counselling.

All provisionally selected candidates are required to report in person and take admission at BIT Mesra, during working hours by 24th July 2018, failing which their admission offers will be cancelled.

List of documents to carry at time of reporting for admission:

At the time of admission, selected candidates would be required to show the originals of the following documents/ certificates **and submit the College Leaving Certificate, Migration Certificate & Caste certificate in original along with self-attested photocopies of the all documents / certificates. Rest documents / certificates may be withdrawn immediately after verification by submitting “Undertaking Form”.**

1. Pass certificate of Class 10
2. Marksheet of Class 10
3. Marksheet of Class 12 / Intermediate or equivalent
4. Marksheets of Graduation for graduates
5. Certificates and marksheets of qualifying examination
OR
Marksheets upto pre-final year for appearing candidates of graduation / qualifying examination in 2018. They must bring a certificate in original from the Principal of Institute stating that:
 - (a) by 30 June 2018, (s)/he will have appeared for examination in all subjects required for obtaining his/her qualifying degree.
 - (b) (s)/he has obtained requisite marks or equivalent based on latest available grades / marks.
6. **Candidates with qualifications acquired through correspondence or distance-learning programmes must carry proof of pass certificate and marksheets of qualifying examination and approval of DEC (Distance Education Council).**
7. Caste certificate / special category certificate (if applicable).
8. College Leaving Certificate
9. Migration Certificate
10. One recent passport size photograph, identical to the photograph uploaded in the online application form.
11. Requisite Admission Fee
12. **Candidates who have appeared for final examinations in 2018 (i.e. whose complete set of marksheets upto final year are not available) will be required to bring an undertaking on Non-Judicial Stamp Paper of Rs. 20/- (please see PG 2018 Information Brochure 2018 (pdf) on website for format of undertaking).**

Admission will be offered subject to submission & verification of original documents / certificates.

***Provisionally selected candidates who have appeared for final examinations in 2018 will be required to sign an undertaking at the time of admission on Non-Judicial Stamp Paper of Rs. 20/- to the effect that if they fail to obtain the requisite marks in graduation / postgraduation their admission will be cancelled. The deadline for submission of mark-sheet / degree certificate is 31 October 2018, failing which the provisional admission will be cancelled.**

Total fees payable at the time of admission:

Provisionally selected candidates will be required to deposit an amount of Rs. 1,08,000/- (for detail, please see Institute website) by crossed demand draft in favour of “**Birla Institute of Technology**”, payable at **Ranchi**. The candidate may also pay the admission fee through State Bank Collect by using the net banking or credit card payment of any nationalized bank. For detail, please see Institute website. **No partial payment shall be entertained.**

In addition to the above, students will also be required to deposit Hostel Caution Money* (One Time only - Refundable) of Rs.5,000/- and suitable mess advance at the beginning of each semester, which will be adjusted against their mess charges. For the July 2018 session, this mess advance* will be Rs. 20,000/- [Total of Rs. 25,000/-].

*Hostel Caution Money (One Time only - Refundable) and Hostel Mess Advance (each semester) are payable by crossed Demand Draft in favour of “**BIT Welfare Society**” payable at Ranchi.

Registration of admitted candidates will be done immediately after admission. Classes have already been commenced from 16th July 2018.
