## **Provisional selection lists for M.Tech. (ECE) and M.Tech. (Information Security) Programs 2018 at Mesra & Patna Campuses**

Following are the lists of candidates provisionally selected on merit for the full-time M.Tech. Electronics & Communication Engineering and M.Tech. Information Security Programs at Mesra and Patna Campuses, based on their academic records, GATE scores and Counselling (for GATE candidates) and Institute Entrance Test and Counselling (for Non- GATE candidates) held at Mesra & Patna Campuses on **04 July 2018**.

**All provisionally selected candidates are required to report in person and take admission at the campus of selection, during working hours on any day by 13<sup>th</sup> July 2018, failing which their admission offers will liable to be cancelled. The Institute will remain closed on Saturday and Sunday.** Details of vacant seats existing after 13<sup>th</sup> July 2018, if any, will be notified on the Institute website on or **before 15<sup>th</sup> July 2018**, along with necessary details.

### **List of documents to carry at time of reporting for admission:**

At the time of admission, selected candidates would be required to show the originals of the following documents/ certificates and submit the **College Leaving Certificate, Migration Certificate & Caste certificate in original along with self-attested photocopies of the all documents / certificates. Rest documents / certificates may be withdrawn immediately after verification by submitting "Undertaking Form"**.

1. Pass certificate of Class 10
2. Marksheet of Class 10
3. Marksheet of Class 12 / Intermediate or equivalent
4. Marksheets of Graduation for graduates
5. Certificates and marksheets of qualifying examination

OR

Marksheets upto pre-final year for appearing candidates of graduation / qualifying examination in 2018. They must bring a certificate in original from the Principal of Institute stating that:

- (a) by 30 June 2018, (s)/he will have appeared for examination in all subjects required for obtaining his/her qualifying degree.
  - (b) (s)/he has obtained requisite marks or equivalent based on latest available grades / marks.
6. **Candidates with qualifications acquired through correspondence or distance-learning programmes must carry proof of pass certificate and marksheets of qualifying examination and approval of DEC (Distance Education Council).**
  7. Admit card and Score card of GATE 2016 / GATE 2017 / GATE 2018 (if applicable).
  8. Caste certificate / special category certificate (if applicable).
  9. College Leaving Certificate
  10. Migration Certificate
  11. One recent passport size photograph, identical to the photograph affixed in the application form.
  12. Requisite admission fee
  13. **Candidates who have appeared / are appearing for final examinations in 2018 (i.e. whose complete set of marksheets upto final year are not available) will be required to bring an undertaking on Non-Judicial Stamp Paper of Rs. 20/- (please see PG 2018 Information Brochure 2018 (pdf) on website for format of undertaking).**

**Provisionally selected candidates who have appeared for final examinations in 2018 will be required to sign an undertaking at the time of admission on Non-Judicial Stamp Paper of Rs. 20/- to the effect that if they fail to obtain the requisite marks in graduation / postgraduation their admission will be cancelled. The deadline for submission of mark-sheet / degree certificate is 31<sup>st</sup> October 2018, failing which the provisional admission will be cancelled. (Please see PG Information Brochure 2018 (pdf) on website for format of undertaking)**

Provisionally selected candidates will be required to deposit an amount of Rs.1,31,000/- for admission at Mesra and Rs. Rs.1,30,500/- for Admission at Patna campus by crossed demand draft in favour of “**Birla Institute of Technology**”, payable at city where campus is located. **The candidate may also pay the admission fee through State Bank Collect by using the net banking or credit card payment of any nationalized bank.** For detail, please see Institute website. No partial payment shall be entertained.

**Students at Mesra & Patna Campuses will be required to deposit Hostel Caution Money\* (One Time only - Refundable) of Rs.5,000/-. They will also be required to pay suitable mess advance at the beginning of each semester, which will be adjusted against their mess charges. For the July 2018 session, this mess advance will be Rs. 20,000/- for Mesra\* and Rs. 15,000/- (boys) and Rs. 10,000/- (Girls) at Patna Campus.**

\*For BIT Mesra - Hostel Caution Money (One Time only - Refundable) and Hostel Mess Advance (each semester) are payable by crossed Demand Draft in favour of “**BIT Welfare Society**” payable at **Ranchi**.

**Registration of admitted candidates will be done immediately after admission. Classes will commence from 16<sup>th</sup> July 2018 at all Campuses.**
