Counselling and Test Schedules for M.Pharm Programme 2018

The schedule of test and counselling for the M.Pharm. Programme 2018 of the Institute is as given below. Candidates who have applied and are eligible for the above programme (as given in the PG Information Brochure 2018 (pdf) on website) should come for counselling of GPAT qualified candidates and test and counselling of Non-GPAT candidates on the date given below. The list of eligible candidates called for test and counselling will be uploaded on the Institute website by 18th June 2018.

Candidates may please note the following:

- Eligible candidates, who have applied for the M.Pharm. Programme 2018, including sponsored candidates, are advised to reach the campus at Mesra by 8:30 am on their respective date and report at **Department of Pharmaceutical Science & Technology by 9:00am.**
- The venue of counselling for above programme will be the Office of the Head of the Department of Pharmaceutical Science & Technology.
- Counselling of eligible GPAT qualified candidates (including sponsored candidates) will be from 9:30 am on their respective date.
- Non-GPAT candidates (including sponsored candidates who have not qualified in GPAT) will first
 be required to appear in an Entrance Test to be held from 9:30 am on their respective date and
 their counselling will commence from 1:30 pm on the same day or as notified by the Department
 after the test. The Department will notify the venue of their Entrance Test. However, their
 admission will be considered only after applicants who have qualified in GPAT 2017 or GPAT
 2018 have been considered and admitted and subject to the availability of seats.

At the time of the counselling, candidates will be required to produce the following documents and certificates **in original** and also submit self attested copies of such documents.

- 1. Pass certificate of Class 10
- 2. Marksheet of Class 10
- 3. Marksheet of Class 12 / Intermediate or equivalent
- 4. Certificates and marksheets of graduation / qualifying examination OR

Marksheets upto pre-final year for candidates who would be completing qualifying examination in 2018. They must bring a certificate in original from the Principal of Institute stating that:

- a) by 30 June 2018, (s)/he will have appeared for examination in all subjects required for obtaining his/her qualifying degree.
- b) He/she has obtained requisite marks or equivalent based on latest available grades / marks.
- 5. Admit card and Score card of GPAT 2017 or GPAT 2018 (if applicable)
- 6. Caste certificate / special category certificate (if applicable).
- 7. Two passport size photographs, identical to the photograph uploaded in the online application form.
- 8. Photo identification: (Driving license, Passport, PAN Card, Voter ID, Aadhaar Card, College ID, Employee Identification Card are acceptable).

Provisionally selected candidates will be required to submit all the above Documents / Certificates (except photo ID) in original at the time of admission.

Provisionally selected candidates who have appeared for final examinations in 2018 will be required to sign an undertaking at the time of admission on Non-Judicial Stamp Paper of Rs. 20/- to the effect that if they fail to obtain the requisite marks in graduation / postgraduation their admission will be automatically cancelled. The deadline for submission of mark-sheet / degree certificate is 31 October 2018, failing which the provisional admission will be cancelled.
