Provisional Selection Lists for M.Tech. (CSE Programme 2019- 4th list

Further to our previous notice Ref/Adm/Results/2019/PG-1/MTech-16, dated 27.06.2019, the following waitlisted candidates have also been selected on merit for the full-time M.Tech. Computer Science and Engineering Programme at Mesra, based on their academic records, GATE scores and Counselling (for GATE candidates) and Institute Entrance Test and Counselling (for Non- GATE candidates) held on **16th May 2019**.

All provisionally selected candidates are required to report in person and take admission, during working hours on any day by 16th July 2019, failing which their admission offers will liable to be cancelled. The Institute will remain closed on Saturday and Sunday.

List of documents to carry at time of reporting for admission:

At the time of admission, selected candidates would be required to show the originals of the following documents/ certificates **and submit the College Leaving Certificate, Migration Certificate and Caste certificate in original along with self-attested photocopies of the all documents / certificates.** Rest documents / certificates may be withdrawn immediately after verification by submitting "Undertaking Form".

1. Pass certificate of Class 10
2. Marksheet of Class 10
3. Marksheet of Class 12 / Intermediate or equivalent
4. Marksheets of Graduation for graduates
5. Certificates and marksheets of qualifying examination

OR

Marksheets upto pre-final year for appearing candidates of graduation / qualifying examination in 2019. They must bring a certificate in original from the Principal of Institute stating that:

- (a) by 30 June 2019, (s)/he will have appeared for examination in all subjects required for obtaining his/her qualifying degree.
 - (b) (s)/he has obtained requisite marks or equivalent based on latest available grades / marks.
6. **Candidates with qualifications acquired through correspondence or distance-learning programmes must carry proof of pass certificate and marksheets of qualifying examination and approval of DEC (Distance Education Council).**
 7. Admit card and Score card of GATE 2017 / GATE 2018 / GATE 2019 (if applicable).
 8. Caste certificate / special category certificate (if applicable).
 9. College Leaving Certificate
 10. Migration Certificate
 11. One recent passport size photograph, identical to the photograph affixed in the application form.
 12. **Candidates who have appeared / are appearing for final examinations in 2019 (i.e. whose complete set of marksheets upto final year are not available) will be required to bring an undertaking on Non-Judicial Stamp Paper of Rs. 20/- (please see PG 2019 Information Brochure 2019 (pdf) on website for format of undertaking).**

Provisionally selected candidates who have appeared for final examinations in 2019 will be required to sign an undertaking at the time of admission on Non-Judicial Stamp Paper of Rs. 20/- to the effect that if they fail to obtain the requisite marks in graduation / postgraduation their admission will be cancelled. The deadline for submission of mark-sheet / degree certificate is 31st October 2019, failing which the provisional admission will be cancelled. Total fees payable at the time of admission:

Provisionally selected candidates will be required to deposit an amount of Rs.1,41,500/- at the time of admission. All payments must be made online through State Bank Collect. For details, please go through the instructions given on the Institute website. **[Candidate may use the net banking or credit card payment through any nationalized bank].**

In addition to the above, students will be required to deposit Hostel Caution Money* (One Time only - Refundable) of Rs.5,000/-. They will also be required to pay suitable mess advance at the beginning of each semester, which will be adjusted against their mess charges. For the July 2019 session, this mess advance* will be Rs. 20,000/- [Total of Rs. 25,000/-].

*Hostel Caution Money (One Time only - Refundable) and Hostel Mess Advance (each semester) are payable by crossed Demand Draft in favour of **"BIT Welfare Society"** payable at **Ranchi**.

Candidates are advised to come prepared to take admission and join classes immediately.
