Marksheets upto pre-final year for appearing candidates of graduation / qualifying examination in 2022. They must bring a certificate in original from the Principal of Institute stating that:

- (a) by 30th June 2022, (s)/he will have appeared for examination in all subjects required for obtaining his/her qualifying degree.
- (b) (s)/he has obtained requisite marks or equivalent based on latest available grades / marks.
- 6. Candidates with qualifications acquired through correspondence or distance-learning programmes must carry proof of pass certificate and marksheets of qualifying examination and approval of DEC (Distance Education Council).
- 7. Caste certificate / special category certificate (if applicable).
- 8. College Leaving Certificate
- 9. Migration Certificate
- 10. One recent passport size photograph, identical to the photograph affixed in the application form.
- 11. Candidates who have appeared / are appearing for final examinations in 2022 (i.e. whose

complete set of marksheets upto final year are not available) will be required to bring an undertaking on Non-Judicial Stamp Paper of Rs. 20/- (please see PG 2022 Information Brochure 2022 (pdf) on website for format of undertaking).

Provisionally selected candidates who have appeared for final examinations in 2022 will be required to sign an undertaking at the time of admission on Non-Judicial Stamp Paper of Rs. 20/-to the effect that if they fail to obtain the requisite marks in graduation / Post-graduation their admission will be cancelled. The deadline for submission of mark-sheet / degree certificate is 31st October 2022, failing which the provisional admission will be cancelled.
