Time: 10:30 AM to 12:30 PM IST (2-hour duration)

Pattern of question: Multiple Choice Questions

Total Marks: 100 (Full marks for each correct answer). There will be no negative marking.

The written test for the Ph.D. Program shall be multiple choice type of questions for 100 marks (50 marks of General and 50 Marks of Applied Subject/ Domain/Department Specific) and for the duration of **two hour**. The type of multiple-choice and/or subjective types of questions will follow the sample pattern of NET and GATE/GPAT. There will be no negative marking.

Note: All applicants are required to report at the campus by 9:30 am. On reporting, may consult to the Office of Examination, regarding Examination Hall etc.

Date of Interview:

The interview of the selected candidates will be conducted as per the schedule given below:[Qualified / eligible candidates of written test will be called for interview].

Reporting Time: 03:00 PM at the concerned department

Documents required during interview:

Candidates are advised to carry the following documents / certificates in original during the interview alongwith a set of photocopies of the same:

1. Application form with valid identity proof
2. Marksheet of Class 10
3. Marksheet of Class 12 / Intermediate or equivalent
4. Certificate and Marksheets of Graduation
5. Certificate and Marksheets of Post-graduation
6. Candidates with qualifications acquired through correspondence or distance-learning programs are eligible only if (a) they acquired such qualifications as working professionals / while in employment, (b) the programs are recognized by the DEC-UGC-AICTE or MHRD, (c) they have passed the qualifying examination at the time of applying, with minimum requisite marks as given in eligibility criteria. They will be required to show (i) work experience certificate (ii) passcertificate and marksheets of qualifying examination (iii) proof of the program recognized by the DEC-UGC-AICTE or MHRD in letter head of the Institute/College /University, with their application.
7. Score card and letter of UGC-CSIR/DBT/BINC/ICMR JRF and all other similar all India fellowships based on a written test for pursuing Ph.D. (if applicable)
8. **Caste certificate / special category certificate (if applicable) in proper format, signed by appropriate authority.**
9. Sponsorship letter, NOC, Experience Certificate and Facilities available to carry out the research at their place of work (if applicable) for Sponsored / Part-Time candidates.

Selection Procedures:

Provisional selection to the Ph.D. Program will be based on performance of the applicants in Written Test, Previous Academic Performance and an Interview. Only such candidates, who obtain the minimum requisite marks in Written Test will be considered for final preparation of result.

Note: **Upto 20% of the selected candidates for admission to the respective Department may be allotted to Part-Time candidates depending upon their position in the merit list. However, in the departments such as Management and Architecture & Planning, the number of selected part-time candidates may be more than 20% and shall be decided by an appropriate committee.**

Exemption from the Entrance Test:

Those with UGC-CSIR/DBT/BINC/ICMR-JRF and all other similar all India fellowships based written test for Ph.D. admission may be exempted from the Written Test, but the candidate has to appear in the interview. [Exempted candidates will not be entitled for any kind of financial assistance from the Institute].

Note: **The Admissions Office / concerned Departments may not undertake detailed scrutiny of applications before interviews. Merely being allowed to appear in the Test will not be considered as a ground for being eligible for admission to the Ph.D. program.**
