5. Photocopy of Academic Bank of Credit (ABC) card
6. Proof of seat acceptance fee payment by net banking/debit card/credit card, or State Bank of India e-challan
7. Certificate of category (SC/ST), if applicable, issued by the competent authority
8. Certificate of category GEN-EWS, if applicable, issued by the competent authority. The certificate must have been issued on or after 1st April 2026
9. Certificate of category (EBC/OBC), if applicable, issued by the competent authority. The certificate must have been issued on or after 1st April 2026
10. Valid Certificate for Persons with Disabilities (PwD), issued by a duly constituted Medical Board. The certificate is valid for 5 years where the disability is temporary, or permanently where the disability is permanent. Certificates not issued by a Medical Board, or invalid/expired on the date of reporting, shall not be accepted. A minimum disability of 40% is required to be eligible for any concessions/benefits

Academic Bank of Credit (ABC) ID Creation

Students who have not yet created their Academic Bank of Credit (ABC) ID are advised to do so as per the process mentioned below.

Creation of ABC ID

Complete process for student registration and login at the Academic Bank of Credit website:

- Step 1. Go to the website <https://www.abc.gov.in>
- Step 2. Go to the “Account” section and click the “Student” link.
- Step 3. Sign up with DigiLocker and complete the ABC Scheme student registration process by providing the requisite details.

Students can then sign in to DigiLocker and download their ABC ID card from the ABC console.

Follow-up for Students

- Visit the ABC website, www.abc.gov.in, to understand the ABC Scheme completely.
- Read the instructions and guidelines regarding the registration process through Aadhaar number on DigiLocker.
- Download and install DigiLocker from the Google Play Store/Apple Store.
- All academic credentials, including credit courses, transcripts, certificates and degrees, will be available on the institutional NAD portal and DigiLocker in the future.
