## BIT Financial Assistantship for the Session Spring (SP) 2026

The applications for awarding BIT Financial Assistantship for the session SP 2026 based on the results of MO 2025 are invited from the students for the following categories:

### Category-1. BIT Financial Assistantship on Sudden Demise of the Earning Member of the Family:

Financial assistantship will be given to the students facing financial hardship due to sudden and untimely demise of the parents (sole earning member) during the period of the course. The students will get assistantship if there are no earnings in the family. The students need to clear all courses in the MO 2025. The students are required to submit the following documents mandatorily.

- Death Certificate.
- Latest Income Certificate of parents issued by a Gazetted Officer not below the rank of CO/SDO/Tehsildar/ ITR of the parent (earning member), if any.

### Category-2. BIT Financial Assistantship to the Staff Wards:

Financial assistantship will be given to the ward(s) of the employees (maximum two and or one in each program) based on the basic or consolidated pay of the employees.

The staff wards applying for financial assistantship are required to submit the following documents mandatorily.:

- Latest Salary Slip of Employee (Father / Mother)
- Latest Income Certificate of parents issued by a Gazetted Officer not below the rank of CO/SDO/Tehsildar or ITR (to be submitted in case of income from other sources such as pension etc.)

Interested students who have not applied or received any other scholarship/ freeship/ financial aid (during SP 2026 based on the results of MO 2025) from other sources, may submit application online through **Google Form (using Institute Email Id)** fulfilling the eligibility criteria as laid down in the guidelines for the BIT Financial Assistantship. Students are advised to review the guidelines carefully to ensure their eligibility before filling out the application form.
