GP Birla Scholarship for the Session MO 2024 for Students admitted through JEE (Main) or Equivalent Entrance Examinations

The applications for awarding GP Birla Scholarship for the session MO 2024 based on the results of SP 2024 are invited from the students for the following categories:

- 1. GP Birla Scholarship based on Merit
- 2. GP Birla Scholarship based on Merit-cum Means to the Economically Weaker Section (EWS)
- 3. GP Birla Scholarship to the Economically and Socially Challenged Students (ESCS)

Interested students who are not recipient of any other scholarship/ freeship/ financial aid from other sources, may submit application online through **Google Form** for one or more categories subject to the eligibility as laid down in the guidelines for the GP Birla Scholarship. However, they will be considered for single category only depending on their eligibility. **Students are advised to go through the guidelines carefully before filling the application form**.

Further, the students are advised to submit the hard copy of the application along with the **following documents mandatorily against** the category as under for which they are applying:-

Category-1 [GP Birla Scholarship based on Merit] :-

Rank Card (AIR) in JEE (Main) or Equivalent Exam – applicable for students admitted in MO 2024. The SGPA (obtained in SP 2024) of the students admitted prior to MO 2024 will be taken from Examination Office.

Category-2 [GP Birla Scholarship based on Merit-cum Means to the Economically Weaker Section (EWS)] :-

Latest Income Certificate and EWS Certificate of parents issued by a Gazetted Officer not below the rank of CO/SDO/Tehsildar. No other document related to income will be entertained.

Category-3 [GP Birla Scholarship to the Economically and Socially Challenged Students (ESCS)] :-

Latest Income Certificate and Caste Certificate of parents issued by a Gazetted Officer not below the rank of CO/SDO/Tehsildar No other document related to income will be entertained.

GP Birla Scholarship (Prize) to the Program Topper: The merit list of the program toppers will be announced based on the SGPA obtained by the students in SP 2024. Their details will be taken from Examination Office and merit list will be published accordingly. Students are not required to apply for it. Incase two or more students in the same semester or branch have achieved the identical SGPA, the prize of Rs. 15,000/- will be distributed among them. Although all of them will get the merit certificate.

The completed application form along with the required documents as mentioned, may be submitted in the office of DoSA. Students belonging to Off Campuses must submit their application to the respective BIT Off Campus only. It may be noted that incomplete or ineligible applications (without requisite documents) will be rejected and not be considered. No communication in this regard will be entertained.

Last date for submission of application (hardcopy) is 22.03.2025.
