## **G.P. Birla Scholarship for the Session Spring (SP) 2026 for Students admitted through JEE (Main) or Equivalent Entrance Examinations**

The applications for awarding G.P. Birla Scholarship for the session SP 2026 based on the results of MO 2025 are invited from the students for the following categories:

### **Category-1. G.P. Birla Scholarship based on Merit:**

The scholarship will be awarded based on the SGPA obtained in MO 2025. The SGPA of the students will be taken from Examination Office. Hence, the students are not required to submit any document, but they must submit the application form along with undertaking.

### **Category-2. G.P. Birla Scholarship based on Merit-cum-Means to the Economically Weaker Section (EWS):**

The Students (Economically Weaker Section) belonging to the General Category (not covered under SC, ST, or OBC reservations) may apply for scholarship on the basis of merit-cum-means. The students will be eligible to apply under this category provided they fulfil the criteria mentioned hereunder:

- > 8.00 SGPA in MO 2025**
- No backlog course in the previous semester(s)**
- Parents' annual income from all sources should be < 8.00 lakh**

The students are required to submit the following documents mandatorily issued by a competent authority not below the rank of Tehsildar, Sub-Divisional Magistrate, District Magistrate, or Circle Officer:

- Latest EWS Certificate and/or valid till 30<sup>th</sup> June 2026**
- Latest Income Certificate and/or valid till 30<sup>th</sup> June 2026**

### **Category-3. G.P. Birla Scholarship to the Economically and Socially Challenged Students (ESCS):**

The economically and socially challenged students belonging to SC/ST/OBC/EBC/NCL category may apply for scholarship under this category. The students will be eligible for scholarship under this category provided they fulfil the criteria as mentioned hereunder:

- > 7.00 SGPA in MO 2025**
- No backlog course in the previous semester(s)**
- Parents' annual income from all sources should be < 8.00 lakh**

The students are required to submit the following documents mandatorily issued by a competent authority not below the rank of Tehsildar, Sub-Divisional Magistrate, District Magistrate, or Circle Officer:

- Caste/Category Certificate**
- Latest Income Certificate and/or valid till 30<sup>th</sup> June 2026**

### **Category-4. G.P. Birla Prize to the Program Topper:**

The merit list of the program toppers will be announced based on the SGPA obtained by the students in MO 2025. The SGPA will be taken from Examination Office and merit list will be published accordingly. Students are not required to apply for this category. In case of a tie in SGPA, the amount of Rs. 15,000/- shall be equally distributed among the students, while merit certificates shall be awarded to all such toppers.

Interested students who have not applied or received any other scholarship/ freeship/ financial aid (during SP 2026 based on the results of MO 2025) from other sources, may submit application for category 1, 2, and 3 online through **Google Form (using Institute Email Id only)** for one or more categories subject to eligibility as laid down in the guidelines for the G.P. Birla Scholarship. However, they will be considered for single category only depending on their eligibility. Students are advised to review the guidelines carefully to ensure their eligibility before filling out the application form.
