

Resolution: Based on the recommendations of the Viva-Voce Board, the Academic Council approved the award of Ph.D. degrees provisionally to the 19 Ph.D. Scholars.

AC.113.04 RELATIVE GRADING SYSTEM

The report and guidelines formed by the Committee for Framing Guidelines on Relative Grading System (CFGRGS) are enclosed as *Annexure: AC.113.04*.

A presentation by Dr. S. K. Jain, HoD, Department of Mathematics and Chairman, CFGRGS regarding the proposed guidelines on relative grading system shall be made before the Academic Council.

- Resolution: The proposed guidelines on Relative Grading System was approved with the following recommendations:
 - (a) The system of relative grading shall be applicable only for Under-Graduate (UG) including Integrated M. Sc. students admitted from the academic session 2023 24 (MO 2023) and onwards.
 - (b) The same shall be applicable for both theory as well as sessional courses.
 - (c) The Upper Limit (UL) of Grade A marks and Upper Limit (UL) of Grade F marks shall be set by the Departmental Moderation Committee. The constitution of the said Committee shall be specified by the Office of Dean (Academics).
 - (d) The coordinator for BCA and BBA courses shall be appointed from a faculty/coordinator of Lalpur and for BAM from Jaipur campus, respectively.

Also, Chairman, CFGRGS shall discuss the modalities of feasible implementation of relative grading on ERP Portal (JUNO Campus) in consultation with the ERP Implementation Team, Office of the Dean (Academics) and Examination Office.

AC.113.05 PROPOSAL FROM DEPARTMENT OF MANAGEMENT TO FINALIZE THE COURSE STRUCTURE FOR 03 (THREE) NEW PROGRAMMES: INTEGRATED MBA, MASTER OF DEVELOPMENT MANAGEMENT & MBA (ONLINE)

The Advisory Committee for Academic Programme (ACAP) in its 85th meeting dated 06th October 2023 perused and recommended the following which were approved by the Hon'ble Chairman of the Academic Council are brought before the Academic Council for ratification. *(Annexure: AC.113.05)*
