#### BOG.73.03 RECRUITMENT OF FACULTY DURING 2022-23

With a view to reinforce the academic and research strength of the Institute, the Institute advertised on 01<sup>st</sup> May 2022 for Faculty Recruitment in all 18 Academic Units of BIT Mesra and selection Departments in the Extension Centres. The recruitment process consisted of three stages;

Stage - I Screening as per minimum eligibility criteria and norms.

Stage - II Seminar presentation (on teaching and research) and peer review (online mode).

Stage - III Final selection by Expert Committee (online mode)

975 applications were received from all over India and abroad. After the first round of scrutiny, 488 applications were selected for departmental presentation, to be reviewed and assessed by a panel consisting of HoDs and External/Internal Experts.

248 applications were selected after the departmental presentation for Final Interview. The final Interview panel was chaired by the Vice Chancellor and consisted of the Chancellor's Nominee, three External Experts from other Universities, Dean of Faculty Affairs and Head of Department from respective Departments. The criteria for selection were:

- (a) Knowledge and Academic credentials;
- (b) Research, Publication & Project record;
- (c) Professional career; and
- (d) Recognition and Awards.

The final Interview was conducted in the month of December 2022. Out of Two Hundred and Forty-Eight (248) applicants only Twenty-Five (25) applicants were offered faculty positions in various departments of various centres of BIT Mesra. The entire selection process strictly followed the BIT and UGC Norms.

Meanwhile, based on the selection criteria mentioned above, similar yardsticks were laid for the below-mentioned Internal Promotions and Regularization applicants.

• A total of Eighteen (18) faculty members who have been regularized on the Assistant Professor Post.

 A total of Forty-Three (43) faculty members who have been promoted within the Assistant Professor Cadre (from AL-10 to AL-11) and (AL-11 to AL-12)

• Eight (8) Internal candidates were promoted across the Cadre through open selection from Assistant Professor to Associate Professor and Associate Professor to Professor.

#### BOG.73.04 PROMOTION/UPGRADATION OF STAFF (NON-TEACHING)

The Institute has approximately 109 staff in Group B, 322 staff in Group C and 743 staff in Group D. As per institute norms all such employees are eligible for promotion under Minimum Assured Career Promotion (MACP) scheme after every 10 years.

The last such exercise was conducted in 2019-20 in between similar exercise could not be undertaken due to the COVID-19 Pandemic related difficulties. The institute undertook a thorough exercise to allow internal candidates to apply and take advantage of the provisions of MACP based promotions.

An advertisement was published on 26<sup>th</sup> October 2022, 538 applications were received, 304 were found eligible, out of which, through a rigorous internal exercise based on BoG approved norms, 273 staff were selected for promotion under MACP.

The Institute also is constantly looking out for competent staff for specific assignments. Since the institute bears the burden of an unusually large number of Group C and D staff (1065 approx.). It was decided to explore the possibility of identifying skilled and competent staff and allow them to move up in their career through an open selection process. Accordingly an advertisement was published on 25<sup>th</sup> January 2022, 283 applications were received, out of which, through a rigorous internal exercise based on BoG approved norms 41 were selected. This open selection process were divided into two categories namely (a) for administrative cadre, and (b) for technical cadre.

## BOG.73.05 OPENING/OPERATION OF BANK ACCOUNTS ADOPTING A NEW FUND DISBURSEMENT SYSTEM OF (GOI) THROUGH TREASURY SINGLE ACCOUNT (TSA)

The Government of India is adopting a new fund disbursement system to reduce the cost of Government borrowings and to enhance the efficiency in fund flow, therefore various agencies of the Government of India are bringing autonomous Institutes in a single umbrella of Treasury Single Account (TSA) System. In view of the same the Institute is often advised to open "Zero" balance bank accounts with specified bankers only for various schemes for Research and Development.

It is therefore, proposed to delegate the authority of opening, closing and authorizing signatories for operating the designated bank account with specified bankers only for receiving the R&D project grants for various Government Agencies to the Vice Chancellor of the Institute. He shall take appropriate decision as and when required after exercising due diligence. Authorized signatories for such bank accounts shall be in two groups or of three each. One from each group singing jointly but not to overdraw.

The Registrar of the Institute shall be authorised to communicate with these specified bankers about such opening, closing and name of authorised signatories of bank accounts.

During the intervening period from the last BOG Meeting held on 12.05.2022, 05 of such bank accounts (enumerated below) had to be opened with the then Registrar Col. Sukhpal Singh as an authorised signatory in Group-'A'.

After many rounds of scrutiny and based upon the strength of the proposal and presentation before the Expert Committee, BIT was selected, out of many, to set up an inclusive Technology Business Incubation Centre (i-TBI). One of the requirements to execute this project is the establishment of a Section 8 Company, for which Hon'ble Chairman Sir has approved in principle.



Under the National Initiative for Developing and Harnessing Innovations (NIDHI) supported inclusive Technology Business Incubator (i-TBI) scheme, there was a National Level call by DST from all over the country. After many rounds of scrutiny and based upon strength of the proposal and presentation before expert committee, BIT was selected,out of many, to setup an inclusive Technology Business Incubation Centre (iTBI). Our faculty members and students will get hugely benefited in converting their technological ideas into start-ups, with funding support under this initiative. This will also help us enhance the rankings under ARIIA and NIRF.



Given that the current level of Maturity of Cyber Security posture at BITs is minimal, a step by-step improvement plan is adopted with THREE focus areas for the next 12 months. The Institute already has Core Technology Components like Firewall, Proxy, and WAF. However, there is a need to address the People and Process Aspects, which are currently in the elementary stage.

We propose a phase-wise plan for the same. These phases can run simultaneously with little interdependence as per the convenience of BIT Mesra. However, the process must be initiated at the earliest towards Cyber Resilience.

Phase I: Establishing Basic Security Hygiene and Security Policy.

Phase II: Establishing a Comprehensive Security Framework.

Phase III: Building of Robust Monitoring & Response Capability.
