## **General Terms & Conditions:**

- 1. The above positionis **purely temporary** and will be filled on contractual basis. The position is co-terminus with the project and will be offered initially for a period of 06 months or till termination of the project whichever is earlier. However, the tenure may be extended depending upon the requirement and performance of the candidate.
- 2. The selected candidates shall not claim for any regular appointments at this Institute / ICSSR, as the above positions are purely contractual, non-regular, time bound and are coterminus with the project.
- **3.** The candidate must exhibit capability to adhere to strict timelines and discipline. Non-maintenance of the discipline and failure to perform the assigned duties will make the candidate liable for termination during the appointment period. The Field Investigator may also leave the assignment, on their own volition, by giving one-month notice.

- 4. Candidates should send their filled in application form (in prescribed format) along with duly self-attested copies of certificates and mark sheets, experience certificate, publication (if any) and no objection certificate from the employer in case of currently employed. Only the candidates having essential qualifications would be entertained for the interview. Candidates who are not able to append their essential degree completion certificate will not be eligible to attend the interview.
- **5.** The candidates will be required to produce all the original documents at the time of interview.
- **6.** Mere eligibility will not entitle any candidate to be called for Interview.
- 7. The candidates short-listed for interview/ test will be informed by e-mail. No TA/DA will be paid for appearing in interview/Joining.
