PAYMENT OF FEES AND REGISTRATION FOR MONSOON 2024 [MO 2024]

Payment of Fees for MO 2024 shall be accepted through online mode from 12th July 2024 (Friday) till 02nd August 2024 (Friday) through the following:

1. Through ERP Portal (JUNO Campus)
2. Through NEFT/RTGS using Unique Virtual Account Number (UVAN)

Students making payment of semester fee after availing education loan are required to make their payment ONLY through UVAN and they must match the semester fee as reflected in the student's ERP portal dashboard with the payment being made. Students have to apply for generation of UVAN through ERP which will take two (02) working days for updation. A student should apply for his/her own UVAN as the UVAN generated for each student is unique and students are strictly advised not to share the same with other students failing which the fee payment will not be reconciled.

It may also be noted that for the student paying through NEFT/RTGS, the ERP registration shall commence after 48 hours of the payment.

Registration for MO 2024 shall be done through the ERP Portal (JUNO Campus) as per the dates given below (as per Revised Academic Calendar – MO 2024):

1. Ph.D. Scholars: From 22nd July 2024 (Monday) till 26th July 2024 (Friday)
2. All UG and PG Students: From 29th July 2024 (Monday) till 02nd August 2024 (Friday)

All the students must update their student profile on the ERP mandatorily including uploading of photograph, ABC ID etc. Otherwise, the registration shall NOT be processed. Also, submit **one (01) hard copy of the registration slip** generated from ERP Portal duly signed by the concerned department to the Academic Programme Office on or before the last date of registrations, as applicable.

The classes for all students except 1st semester B. Tech., B. Arch. & Integrated M. Sc. shall commence from 05th August 2024 (Monday). The students shall NOT be allowed to attend classes without registration in MO 2024. The students who do not have any previous dues (semester fees, hostel rent, library dues, mess dues, late fine and any other dues) only can get themselves registered for MO 2024 as per the procedure given above.

The attendance shall be counted from the date of commencement of classes (05th August 2024) irrespective of the date of registration.
