SEMESTER FEE AND REGISTRATION FOR SPRING 2024 [SP 2024]

Payment of Semester Fees for SP 2024 shall be accepted through online mode from 15th December 2023 (Friday) till 07th January 2024 (Sunday) through the following:

1. Through ERP Portal (JUNO Campus)
2. Through NEFT/RTGS using Unique Virtual Account Number (UVAN)

Students making payment of semester fee after availing education loan are required to make their payment ONLY through UVAN and they must match the semester fee as reflected in the student's ERP portal dashboard with the payment being made. Students have to apply for generation of UVAN through ERP which will take two (02) working days for updation. A student should apply for his/her own UVAN as the UVAN generated for each student is unique and students are strictly advised not to share the same with other students failing which the fee payment will not be reconciled.

It may also be noted that for the student paying through NEFT/RTGS, the ERP registration shall commence after 48 hours of the payment.

Registration for SP 2024 shall be done through the ERP Portal (JUNO Campus) as per the dates given below (as per Academic Calendar-SP 2024):


1. Ph.D. Scholars: From 16th December 2023 (Saturday) till 19th December 2023 (Tuesday)
2. All UG and PG Students: From 20th December 2023 (Wednesday) till 07th January 2024 (Sunday)


All the students must upload a valid ABC ID before the commencement of mid semester examinations. Otherwise, the hall ticket for the said examinations shall NOT be generated.


The classes for all UG and PG students shall commence from 08th January 2024 (Monday). The students shall NOT be allowed to attend classes without registration in SP 2024. The students who do not have any previous dues (semester fees, hostel rent, library dues, mess dues, late fine and any other dues) ONLY can get themselves registered for SP 2024 as per the procedure given above.

The attendance shall be counted from the date of commencement of classes (08th January 2024) irrespective of the date of registration.
