This has reference to Appeal dated **12-07-2023** filed by **Birla Institute of Technology, Mesra, Ranchi-835215**, **Jharkhand** against non-accreditation to the **PG** – **Remote Sensing** program of your Institution communicated vide NBA's letter of even number dated **27-06-2023**.

2. The Appeal has been considered in NBA. The Representatives of the Institution also presented the case before the Appellate Committee of NBA in its meeting held on **14-12-2023**. The recommendation of the Appellate Committee has been considered by the Competent Authority in NBA. Based on the decision taken, accreditation status of the **PG** – **Remote Sensing** program is given in the table below:

This has reference to NBA's letters of even number dated 28-07-2016 under which six **PG Engineering** programs offered by your institution were granted provisional accreditation for 2 years in Tier-I by National Board of Accreditation.

2. National Board of Accreditation (NBA) has decided that in all cases where PG Engineering programs of an Institution were granted provisional accreditation for a period of 2 years the period of accreditation of these programs shall be extended from 2 to 3 years subject to the condition that they meets the essential pre-visit qualifiers. The pre-visit qualifiers in respect of the programs submitted by Birla Institute of Technology, Mesra, Ranchi— 835215, Jharkhand. The following PG engineering programs meets the essential parameters of pre-qualifiers. - 3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.
- 4. The programs have been granted accreditation upto 30-06-2019. Birla Institute of Technology, Mesra, Ranchi—835215, Jharkhand should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above to be eligible to be considered by the concerned Committee in NBA for further processing of the accreditation status. This could entail further extension of accreditation or a revisit, as deemed appropriate by NBA Committees.
