NOTICE BRANCH CHANGE

Applications for branch change are invited from interested students who have completed first year of the Bachelor of Technology (B.Tech.) & Integrated Master of Science (Int. M. Sc.) in Physics i.e. the students admitted in the A.Y. 2023-24 [MO 2023].

Students who have completed all the examinations of the first two semesters in the first attempt and have an average SGPA (first and second semesters) of 8.00 or above for General/EWS/OBC/EBC and 7.00 or above for SC/ST may apply through the Google Form for Branch Change on or before 04th August 2024 (Sunday).

Please note that seats shall be filled category wise in which the student had taken admission. Hence, the students are advised to mention the same category in which he/she had taken admission.

The students also need to upload the following documents in the Google Form:

- (i) Photograph
- (ii) Copy of Grade Card/Results of the first and second semesters
- (iii) Copy of Category Certificate
- (iv) Copy of JEE (Main) Rank Card for CRL

Note:

- 1. Branch change will be done strictly in order of merit, availability of vacancies and preference basis.
- 2. A student must have completed all the prescribed credits of the first two semesters in the first attempt.
- Students having received any fail grade (F/F*/UFM) in any course will not be eligible for branch change.
- 4. Students should not have faced any disciplinary action or indulged in an act of indiscipline.
- Students admitted under Gol/NRI/PIO/OCI/SFFS are not eligible for branch change.
- In case of a tie between two or more students, branch change shall be done based on CRL of JEE (Main).
- Maximum 10% of the existing students of any branch shall be allowed to change to another branch. However, branch change shall be permitted subject to having minimum strength in a discipline/branch.
