## NOTICE REGARDING REVISED ACADEMIC PROGRESSION POLICY

As per the recommendation of the 105<sup>th</sup> Meeting of the Advisory Committee for Academic Programme (ACAP) held on 08<sup>th</sup> January 2025, Clause – III; Point 2, 3 & 4 of the Examination Regulations have been revised vide agenda item ACAP.105.08 as follows:

- Students of 3 Year UG programmes (BBA, BCA, B.Sc. etc.) admitted in A.Y. 2023-24 [MO 2023] shall be permitted to register in the 4<sup>th</sup> semester as below:**
  - Without any backlogs in the 1<sup>st</sup> and 2<sup>nd</sup> semester OR
  - With backlogs up to a maximum of **three (03)** courses till the 3<sup>rd</sup> semester
- Students of 2 Year PG programmes (MBA, MCA, M.Sc., M. Tech., MUP, M. Pharm. etc.) admitted in A.Y. 2023-24 [MO 2023] shall be permitted to register in the 4<sup>th</sup> semester as below:**
  - Without any backlogs in the 1<sup>st</sup> and 2<sup>nd</sup> semester, OR
  - With backlogs up to a maximum of **two (02)** courses till the 3<sup>rd</sup> semester
