Through State Bank Collect

: From 5th July 2021 (all UG, PG Ph.D. Students)

Hostel Mess Advance (For Mesra Campus only)

"Students who have dues in Mess Account may check their respective dues amount on the website of BIT Welfare Society (www.bitwelfaresociety.com). Payment can be done through the SBI Collect link provided in the website itself. Roll nos. to be typed in CAPS with last two digits of year only. (e.g. B.TECH/10001/19).

Hostel Seat Rent for Students of Mesra Camps and Off-campuses

- ➤ In order to meet out the Hostel expenditure towards housekeeping, security, building maintenance, electricity etc, only 50% of the Hostel Seat Rent (HSR) will be charged during MO 2021 semester. Keeping in view of the current situation, the Institute shall provide a discount of 50 % in HSR.
- ➤ The students registering for IIIrd semester are hereby informed that 50% of HSR will be realised from the amount already deposited by them at the time their admission in MO 2020.
- In view of the COVID 19 Pandemic, it may be noted that students are not allowed to come to the Institute under any circumstances until the normal situation resumes. However, as per the directives of the Central / State Govt., the Institute shall notify for physical reporting of the students to the campus.

- Further, It may be noted that if going forward the students return to the campuses and reside in his/her hostel room during MO 2021, the balance amount of hostel seat, electricity and transportation etc shall be required to be paid in full by the concerned students.
- 1. State Bank Collect for fee payment (all UG, PG and Ph.D. Students)

- >> Select Category "Semester Fee" (all UG and PG students), "Ph.D. Semester Fee" (all Ph.D. students) and fill all given details
- >> Click "submit"
- >> Payment Option: Net Banking/ Credit Card /E-Challan.
- 2. <u>Payment Through Bank Loan only:</u> Students of Mesra campus as well as Off-campuses who are availing educational loan from banks can make the fee payment using ERP portal or SB COLLECT by generating NEFT/RTGS Challan.

Please ensure that if the student avails their education loan from State Bank of India then they are required to make an E-Challan and if the banker is other than State Bank of India then they have to generate NEFT/RTGS Challan. You are requested to ensure that when the payment is made, Challan amount must match with the remittance amount. It may be noted that for the students paying through SB Collect, the ERP registration shall commence after 72 hours of payment.

Students who are not having any previous dues (semester fee, hostel mess dues and library dues) till SP 2021 and have paid the fee for MO 2021 can get themselves registered in ERP from <u>15th July 2021</u> onwards.

"Payment of MO 2021 semester fee is mandatory. Online registration through ERP will be enabled only on the receipt of MO 2021 semester fee, and other previous dues".

Students are advised to register their courses online. Hard copies of the registration form are not required to be submitted now and the same may be submitted after the resumption of normal activities of the Institute.
