**REVISED NOTICE**

**Attention: All U.G., P.G. & Ph.D. Students**

Payment of Semester Fee for MONSOON – 2018 Session onwards will be accepted through online mode from dates given below:

1. Through Payment Gateway: - 5<sup>th</sup> June 2018 to 29<sup>th</sup> June 2018 (All UG & PG except Ph.D)
2. Through State Bank Collect: - 5<sup>th</sup> June 2018 to 30<sup>th</sup> June 2018 (For UG)
3. Through State Bank Collect: - 5<sup>th</sup> June 2018 to 4<sup>th</sup> July 2018 (For PG & Ph.D.)

All UG Students who have not paid online fee by above mentioned dates can pay **ONLY** through **Demand Draft** mode thereafter with applicable late fine as per their date of registration.

The payment of **Semester Fee** for UG and PG courses can be made through online payment gateway link available at our Institute website as well as through SB – Collect, while Ph.D. courses through SB – Collect only.

The payment of **Mess Fee** for UG, PG & Ph.D. Courses can be made through online payment gateway link available at BIT WELFARE SOCIETY ([www.bitwelfaresociety.com](http://www.bitwelfaresociety.com)) as well as through SBI Collect only as per the above mentioned dates. No other mode of payment will be accepted. All the information pertaining to the Mess Fee is available at BIT Welfare Society Website only.

**Indian Student's, other than those admitted through NRI Quota can pay their fees online as follows:**


1. Type the browser [www.bitmesra.ac.in](http://www.bitmesra.ac.in) and choose Online Fee Payment  
Click Proceed >>, then enter Roll No. >> Date of Birth (dd/mm/yyyy)  
>> Click "Proceed" button  
>> Click "Pay Now"  
>> Payment Option: Net Banking / Debit Card / Credit Card Option
2. State Bank Collect: Type link

>> Click on the Check Box to proceed for payment then "Proceed",  
>> Select Category "Semester Fee", >> Enter "Roll Number" (In Capital)  
>> Click "submit"  
>> Payment Option: Net Banking/ Credit Card /E-Challan.

After successful payment of their Institute fees, students are advised to take print out of the payment receipt mandatorily by using the option "**Print & Save**".

Students who are not having any previous dues and have paid the fee for MO'18 can get themselves registered in ERP from **15<sup>th</sup> Jun, 2018** onwards. It may be noted that Registration Process done by using the BIT website ERP can be initiated only after 72 hours of successful online payment.

***"It is compulsory to pay both Semester Fee and Mess Fees for MO-18, only then Online Registration via ERP can be done by students."***

Students are advised to register their papers and take print of the form in their respective departments. After registration, students must submit the hard copies of the **registration form**, duly signed by them and HoD/Advisor, **alongwith xerox copy of tuition fee receipt and mess dues clearance receipt** to the Semester Programme Office on the specified date failing which late fine will be charged as applicable and mentioned in the **Academic Calendar** enclosed herewith. The registration process shall be completed on submission of the registration form to the Semester Programme Office.
