- 1. Vendors must be in IT business for atleast 5 years and should be in India for minimum 5 years.
- 2. Vendors must have authorization from OEMs referring tender details(MAF).
- 3. The Vendors should be a company registered under the Indian Companies Act 1956, [Documentary Proof: Certificate of incorporation/Company registration certificate.]
- 4. The Vendors should submit valid Service Tax registration certificates (issued from Govt. of Jharkhand) along with latest Service Tax Return Certificate [submit documents]

The Vendors should have successfully completed/on-going similar projects to any Clients in Academic institute, Govt. or Semi Govt. organization, Corporate with an order value not less than of Rs.25,00,000/- within last 3 years [at least two such type of work with relevant support document enclosed with the document].
