BOG.69.03 ANNUAL ACCOUNTS AND AUDIT REPORT OF FY: 2020 – 2021

Section 10(23C) of the Income Tax Act, 1961 requires that a minimum of 85% of the Income of a Charitable Institution is to be spent during the year, and where more than 15% of the income is accumulated, the period of accumulation of the income shall not exceed five years. As per audited accounts for the year ending 31st March, 2021, the Institute had a total income of Rs. 22770.16 lacs of which 85% amounting to Rs.19434.16 lacs were to be spent during the year. However, during the year an aggregate sum of Rs.17874.16 lacs only (including non-recurring expenditure of Rs.3155.72 lacs) was spent. An amount of Rs.1560.00 lacs has been accumulated and is to be spent in the next five years, for educational purpose.

It was noted that a sum of Rs.1560.00 lacs (Rupees Twenty-two crores only) out of income of the Institute for the year ended 31st March 2021 had been accumulated for spending for educational purpose within a period of five years ending 31st March, 2026 and the said amount will be invested in an approved pattern of investments specified under section 11(5) of the Income Tax Act, 1961.

As recommended by the Finance Committee and upon perusal of the above, the Board approved the Annual Accounts and the Audit Report on Accounts of the Institute, for the year ending March 31, 2021, and recommended the same to be placed before the General Council, for consideration and approval.

The Board was also informed of the fact that the fees collection for Spring Semester-2020 was delayed due to late starting of the Semester, owing to COVID-19 Pandemic; the same shall get reflected in the FY 2021-2022.

BOG.69.04 BUDGET ESTIMATES FOR FY: 2021 – 2022

The proposed budget estimate for Financial Year 2021-22 envisages a cash deficit of Rs.15670.94 lacs which includes non-recurring expenditure of Rs. 14285.34 lacs and deficit of Rs.1385.60 lacs. The Annual Budget estimates for the Financial Year 2021-22 as recommended by the Finance Committee were reviewed and approved by the Board and recommended the same to be placed before the General Council, for consideration and approval.




BOG.69.05 RENAMING OF THE ACADEMIC DEPARTMENT OF ARCHITECTURE

As recommended by the Academic Council in its 104th meeting dated 06.11.2020 the Board approves the renaming of the 'Department of Architecture' as 'Department of Architecture and Planning'.

BOG.69.06 ESTABLISHMENT OF AICTE – IDEA LABORATORY

The Board approved the proposal of establishment of IDEA Lab and also appreciated the efforts of the faculty for bagging the prestigious IDEA (Idea Development, Evaluation & Application) LAB with funding from AICTE, and also approved the proposed financial support of Rs.62.99 Lakhs as Institutional contribution towards (non-recurring and recurring) expenses for establishing the said IDEA Lab.

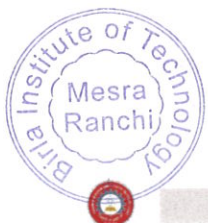
