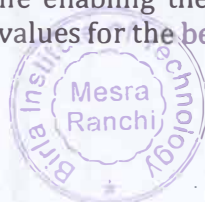
OFFICE ORDER WOMEN'S DEVELOPMENT CELL "SRISHTI"

Role of the Secretary:

- d) Recommendations of the committee shall be duly approved by the Competent Authority.
